

JAIL COMMITTEE MEETING  
MINUTES  
JULY 17 2018

Chairman Tjelmeland called the meeting to order at 1201p.

Tjelmeland requested a motion to approve the minutes of the July 3, 2018 Jail Committee meeting. **Motion was made by Krell & seconded by Ruzic. Motion carried (6-0).**

**REPORTS:**

Sheriff updated the committee on the vivotol program. As of April 20<sup>th</sup>, 3 have completed the program. As of July 10<sup>th</sup>, there have now been a total of 7. 58 are still in the program & 76 are attending substance treatment.

Chief Roesch had nothing to report.

Superintendent Beck reported that the jail count is 352. Overtime for the last couple of weeks has been high. We will have 3 new hires on July 23<sup>rd</sup> and 1 hire on August 6<sup>th</sup>. Sheriff says there has been a lot less turnover compared to last year. Discipline has gone down in the jail. We have yet to have a grievance this year.

Coroner Report-Edwards reported that her office has been very busy. A couple of weeks ago, they had 4 or 5 overdoses (heroin & fentanyl) Edwards said that the man from Pawnee is still missing. Sheriff says they are going to be searching again on Saturday with dogs & volunteers and that his department will have a deputy out there to watch over & organize. Sheriff said that the man is in better shape than they originally thought and that he could walk for miles so it's been a difficult search.

**New Business:**

Tim Eggleston:

- MJ Kellner approval \$11,908.00 Chairman Tjelmeland asked for a motion to approve MJ Kellner. **Preckwinkle made a motion to approve & Krell seconded. Motion carried (6-0)**
- Approval to hire a replacement Control Room Operator effective 7/25/18 or after at a starting salary of \$31,514.00. **DelGiorno made a motion to approve & Ruzic seconded. Motion carried (6-0)**

Chairman Tjelmeland requested a motion to approve the requisitions for the Sheriff & Coroner. **Krell made a motion to approve and Madonia seconded. Motion carried (6-0).**
